

### The State Education Standard

### **Description**

The National Association of State Boards of Education (NASBE) publishes the *State Education Standard* three times annually. Each issue focuses on a specific theme (e.g., teacher quality, school funding, charter schools) but always in the context of how state policy affects what happens in schools and classrooms. Leading education thinkers, policymakers, researchers, and practitioners write for the *Standard*.

# **Purpose**

The *Standard* serves a dual mission: Primarily, it helps policymakers and education leaders understand the complex issues involved in improving their education systems. But it also helps advocates, researchers, and other experts better understand the equally complicated arena of policymaking. Overall, we seek to bring together the best thinking in policy, research, and practice to enable decision makers to drive school improvement.

#### **Format**

There are six to ten magazine-length feature articles per issue. Departments include News & Notes; columns on communications strategy, leadership, and legal issues; a Q&A with policymakers, practitioners, and advocates; and a column by NASBE's president. The *Standard* is 48 to 56 pages in length; dimensions are  $8.5^{\circ} \times 11^{\circ}$ . It is printed in full color.

#### Distribution

The *Standard* is mailed to all members and posted online at <a href="www.nasbe.org">www.nasbe.org</a>. It is also distributed to other decision makers, advocates, foundations, journalists, and education associations. New issues of the *Standard* are distributed at education conferences and meetings and are promoted in NASBE's newsletter, press releases, and to our 18K Twitter followers.

#### Mission

The National Association of State Boards of Education (NASBE) develops, supports, and empowers citizen leaders on state boards of education to strengthen public education systems so students of all backgrounds and circumstances are prepared to succeed in school, work, and life. For over 60 years, NASBE has served as the only membership organization solely for state boards of education.

#### Who Are NASBE Members?

State boards hold a pivotal place in education policymaking. While each state board has a unique context of state governance and authority, the vast majority have influential positions or direct policy authority over statewide learning standards, graduation requirements, accountability and assessment programs, and accreditation and teacher preparation standards. Because their members' terms last from four to nine years, state boards serve as the stable center of state education governance, capable of steering a statewide education agenda to fruition even in the midst of leadership transitions. State boards often set the vision for public education in their states and shepherd policies to advance that vision.

Any individual who sits on a member state board has access to NASBE member services. These boards make decisions that affect over 30 million K-12 public school students. NASBE has two affiliate associations: the National Council of State Board of Education Executives (NCSBEE) and the National Council of State Education Attorneys (NCOSEA).
